an Agreement for the reform of the Assessment System of research, researchers and institutions to improve their quality, performance and impact is under development (EUA, SE, ERAC, ERA Forum, and more than 250 organizations involved)

## **Questions for Research Evaluation**

- Compared to the existing frameworks, what can research evaluation no longer be?
  - A mean for worsening research career
  - A tool for reinforcing inequalities
  - An instrument favouring the publish or perish trend
  - A set of metrics to improve the research performance, not quality
  - A threat for reproducibility of research and research ethics
  - A constraint for research autonomy and academic freedom
  - A barrier to recognize the value of interdisciplinary research and diversities of activities and results
- Need for a new agenda for evaluation -effectiveness concerns, causal links and effects on global communities?
