This special issue, commemorating the **30th anniversary of Universities of Applied Sciences (UAS) in Austria** and IMC Krems, aims not only to celebrate but also to provide a forward-looking perspective on the role of these institutions, particularly in research and innovation. Given the specific challenges in the field of research and development (R&D) at UAS, characterised by clear research mandates and different institutional and budgetary conditions compared to universities, this anniversary offers a unique opportunity to reflect on the **successes**, **challenges**, **and potentials of**

The focus lies on questions of evaluation and the impacts of research performance, including institutional evaluation, research and development processes, quality assurance, available funding, requirements for R&D, and the impacts of this research at UAS and in the broader society.

2 FOCUS OF THE SPECIAL ISSUE

The aim of this collaboration between the fteval platform and IMC Krems is to acknowledge and reflect on the role of **Universities of Applied Sciences (UAS) in the Austrian higher education, research, and innovation system** in the framework of a special issue of the fteval Journal, to be published by mid-2024. Core questions of this special issue revolve around the following themes:

- History and development of UAS in Austria and their performance requirements, especially regarding research activities and processes.
- The **role and impact** of UAS in research and innovation.
- Analysis of political and societal conditions for research and development at UAS.
- Evaluation and quality assurance concerning research processes at UAS.





- Role and effectiveness of funding programs with a specific focus on UAS.
- Research organization and strategies at UAS.
- Integration of R&D results into teaching.
- Successful valorisation of UAS research in technology transfer and knowledge production.
- Identification of future trends and challenges in UAS-related research and higher education policy.

3 CONTRIBUTION FORMATS

The fteval Journal positions itself at the intersection of research and technology policy and academic quality. It contributes to the exchange between various **stakeholder groups in research, technology, and innovation policy**. With regular issues and a broad spectrum of topics, the fteval Journal is **open access**. All articles in the special issue undergo an editorial and international **peer-review process**.

The fteval Journal aims to foster exchange with its audience on systemic reflection, evaluation experiences, and methodological developments. Therefore, classic academic **article submissions**, as well as **practice reports** or **discussion papers**, are accepted. Submissions can be in **German** or **English**, with a preference for submission or final translation into English for international reception and exchange in the evaluation community.
